PERMIT DRAWINGS

Permit drawings can take two to four weeks for garages and custom backyard living. Cabins and homes currently have an estimated three to four weeks lead time. Any additional changes can take up to two weeks.

BACKYARD SHEDS PAVILIONS GARAGES - UNDER \$50,000

Payment Schedule

- 1. 10% down payment at time of order.
- 2. *Final payment is due on the day of build.

The Crews that build or deliver your product are authorized and expect to receive payments from you.

*Garage Doors are generally not scheduled to be installed the same day of the build. Please pay in full for the garage doors even though they aren't installed the day of the final build. If this is not an option please make arrangements with accounts receivable in accounting ahead of time for a customized payment schedule. Phone number 330-852-2103 (Option 3)

GARAGES, CABINS, HOME SHELLS - ABOVE \$50,000

PAYMENT SCHEDULE

- 1. 10% down payment at time of order.
- 2. Additional 40% is due when scheduled.
- 3. Final payment is due on the day of build.

*Garage Doors are generally not scheduled to be installed the same day of the build. Please pay in full for the garage doors even though they aren't installed the day of the final build. TURN KEY HOMES - \$95,000 AND ABOVE

- 1. 10% down payment at time of order
- 2. An additional 10% is due when scheduled.
- 3. An additional 20% is due first day on job site.
- 4. An additional 20% is due at time of shingle install.
- 5. An additional 20% is due after siding and windows installed.
- 6. An additional 10% is due after major appliance install.

7. Final payment is due once job is completed. *Estimated Schedule (Actual will Vary)*

SCHEDULING PROCESS

Time Frame

You will be contacted within ten business days of when your "Accepted Sales Order" is checked as "Site Ready". If your site is complete you will be given either an estimated or confirmed date.

Confirmed Build Date

If you were given a confirmed build date, you will only be contacted again if there are questions or changes to the schedule.

Estimated Build Date

If you were given an estimated build date, you will be contacted to confirm the schedule within ten business days of the build date.

*Any changes made to an "Accepted Sales Order" can affect the build schedule.





SCHEDULING PROCESS

Time Frame

You will be contacted within fifteen business days of the order becoming an "Accepted Sales Order" to discuss the foundation and build a time frame. If your foundation is scheduled or complete, you will be given either an estimated or confirmed build date.

Confirmed Build Date

If you were given a confirmed build date, you will only be contacted again if there are questions or changes to the schedule.

Estimated Build Date

If you were given an estimated build date, you will be contacted to confirm the schedule within fifteen business days of the build date.

*Any changes made to an "Accepted Sales Order" can affect the build schedule.




FOUNDATION OPTIONS

BLOCK SITE PREP

*Not Recommended For Grades Exceeding 8"


Place $8'' \times 16'' \times 4''$ cement blocks underneath the skids. Every skid needs a block at the front and back and then additional blocks need to be placed in the middle spaced not more than 6' apart.



LIMESTONE PAD


*The Most Popular Choice For Sheds

Spread 4" of #57 limestone in a level pad 12" beyond the width and the length of the building on all sides. Also, you may want to use a 4×4 as an edge as shown in the example below.




CONCRETE FOUNDATIONS


Pour the pad 1/2" less than the dimensions of the building. We attached treated plates to the bottom of the walls protecting the walls from moisture and rot. These bottom plates are fastened to the concrete pad with anchors or bolts.




POST PLATFORM FOUNDATION

Use treated posts. Dig the post holes 32"- 42" deep. Place post pad or concrete in the bottom of the hole. Insert posts. Fasten cross beam joists with bolts to posts as shown making sure that the entire structure is square.






SKID PLACEMENT









DOOR ALIGNMENT
